

RESOLUTION NO. 419

**RESOLUTION ACCEPTING A PETITION FOR
ANNEXATION OF THE DONEEN PROPERTY**

WHEREAS, the Board of Commissioners received a petition for annexation into the East Wenatchee Water District of Douglas County, which was signed by Mr. Mike Doneen, owner of not less than sixty percent (60%) of the area of the following described contiguous property:

The Northeast quarter of Section 36, Township 23 North, Range 20 East, W.M., Douglas County, Washington, except the Southwest quarter of said Northeast quarter and except that portion of said Northeast quarter lying east and south of the following described line:

Commencing at the East quarter corner of said Section 36;

Thence Westerly along the South line of said Northeast quarter 530.70 feet to the true point of beginning of said line;

Thence North 07°17'00" West 500 feet;

Thence North 04°00'00" West 653.30 feet;

Thence North 34°30'00" East 380 feet;

Thence North 32°14'00" East 600.50 feet more or less to the South margin of Badger Mountain Road;

Thence South 87°32'00" East 108.6 feet more or less along said South margin to its intersection with the East line of said Northeast quarter and the terminus of said line.

WHEREAS, the Board of Commissioners are satisfied that such annexation petition complies with the requirements of law and, therefore, have determined to entertain the petition by setting a public hearing date and causing proper notice to be published regarding the hearing; and


WHEREAS, the Board of Commissioners, as lead agency for this annexation proposal, will make a threshold determination as to any significant environmental effect and resulting impact statement and address such determination at said public hearing.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners of East Wenatchee Water District of Douglas County, Washington, as follows:

1. East Wenatchee Water District hereby accepts the annexation petition submitted by Mr. Mike Doneen for the above-described property and sets a Public Hearing to be conducted at 3:00 p.m. September 1, 1994, at the District Office located at 692 Eastmont Avenue, East Wenatchee, Washington, and orders proper Notice of Hearing to be published.

2. East Wenatchee Water District hereby proposes a threshold determination of non-significance for the Doneen Annexation of the above-described property and orders that said DNS signed by Charlie Johnston as responsible official for the lead agency be submitted to the Douglas County Boundary Review Board and other interested entities as required by WAC 197-11-340 and be addressed at the Public Hearing set for September 1, 1994.
