In 2016 the East Wenatchee Water District passed Resolution #674 which states that all test reports for backflow assemblies shall be received by **July 31st of each year** to avoid late fees/penalties.

While it is the tester's responsibility to submit the test reports online via SwiftComply.com, we do recommend requesting a copy of the test results for your files as proof of completed testing in case the tester fails to submit in a timely fashion. Testers are required to submit test reports within 10 days of the test date.
