The undersigned ("Applicant") hereby applies for water service to the property described above and affirms that they are the owner, customer, or authorized agent of the owner.

As a condition of service, the Applicant agrees to comply with all current and future rules of the East Wenatchee Water District ("District"), including its cross-connection control program. The Applicant shall install and maintain the property's plumbing system in accordance with the most recent applicable plumbing code, ensuring protection against contamination, pressure surges, and thermal expansion. For thermal expansion, it is assumed that the District has installed a check valve on the service line.

The Applicant waives any claims against the District, its agents, or employees for damages, losses, or interruptions of service resulting from variations in pressure, repairs, maintenance, power outages, or other normal system operations. The District makes no warranty regarding water quality on the customer's side of the meter, including taste, odor, or bacterial growth, and assumes no responsibility for plumbing or equipment beyond the meter vault.

The Applicant's signature above acknowledges and confirms that this agreement is legally binding, and that an electronic signature carries the same legal effect as a handwritten signature.
