RESOLUTION ESTABLISHING SHUT-OFF CHARGES

1 WHEREAS, the Board of Commissioners, after fully considering  
2 all of the factors of cost, service and bookkeeping in the matter  
3 of water shut-off charges for non-payment and other reasons, and having  
4 received advice of their accountant and engineer, and it appearing  
5 reasonable, proper and necessary in the best interest of the public  
6 and consumer within, the Water District, now therefore,

7 IT IS HEREBY RESOLVED that the existing regulations concerning  
8 the payment of service fees be amended and added to as follows:

9 In case of non-payment of fees and charges for water within thirty  
10 (30) days after they are due; the water may be shut off, without  
11 further notice, and a charge of \$5.00 shall be added to cover the  
12 expense of truning the water off and on, and in no case shall water  
13 be turned on again until the amount has been paid in full.


14 All fees for the use of water shall be charged to the owner of,  
15 and are hereby declared to be a lien against the premises to which  
16 water has been furnished.


17 Should it be desired to discontinue the use of all the water  
18 supplied to any premises for a period not less than one calendar  
19 month, written notice must be filed in the office of the East  
20 Wenatchee Water District, which notice shall be on a printed form  
21 provided for that purpose, any payment in full for all arrearage  
22 must be made. The water will then be turned off and then be turned  
23 on again for which a charge of ~~\$2.50~~<sup>1.50</sup> shall be made for each trip to  
24 the premises.
