

RESOLUTION NO. 602

AWARD 2008 BAKER FLATS ULID NO. 2 SUPPLY AND STORAGE

WHEREAS, the East Wenatchee Water District pursuant to R.C.W. 57.08.050 called for bids in connection with the Baker Flats ULID No. 2 project generally described as follows:

Construction of a 1.5 million gallon concrete reservoir, approximately 16,000 feet of 12-inch diameter and 600 feet of 18-inch diameter water main, miscellaneous pipe for tie-ins, flow control valve vault and a directional drilled highway crossing. The Contractor to supply all work materials and equipment necessary for a complete installation with the exception of selected telemetry equipment provided by the District, and

WHEREAS, plans and specifications were prepared by the District's engineer for the above described project and the successful contractor will furnish all the necessary equipment and materials to complete each job as called for in the project contract documents, with the exception of the telemetry equipment provided by the District, and

WHEREAS, the District received sixteen bids (prices include sales tax) to install said water main facilities as follows:

WHEREAS, having reviewed all the bid documents with the District's engineer, it appears that all bids are responsive bids, and therefore it is recommended by the District's engineer that the lowest responsible bid from Selland Construction in the amount of \$3,355,252.20, and

NOW THEREFORE, BE IT HEREBY RESOLVED by the BOARD OF COMMISSIONERS of the EAST WENATCHEE WATER DISTRICT that the lowest responsible bid from Selland Construction in the amount of three million, three hundred fifty five thousand, two hundred fifty two dollars and twenty cents is hereby accepted and a contract for the project will be executed with Selland Construction of Wenatchee Washington.

BE IT ALSO HEREBY RESOLVED, by the BOARD OF COMMISSIONERS of the EAST WENATCHEE WATER DISTRICT, the General Manager is authorized to do all acts necessary to effectuate the Resolution adopted herein.
